April 1999  
Minutes Summary

Meeting called to order by President Gary Cayo. All board members present, except Treasurer Lynne Teller who is attending the FBI National Academy.

Meeting minutes from March 10, 1999, were read by Secretary Cory Manthei. Motion to accept made by G. Pike, second by D. Dixon; motion approved.

Don Peterson submitted treasurer report, in Lynne Teller's absence. Received monies not represented since last report total approximately \$90,000 for conference fees to Breezy Point Resort. Once conference fees are paid, previous totals will again be representative of current balances. Motion to accept made by J. Neuberger, seconded by D. Mathison; motion approved.

##### National Conference: Steve Labatt

Requested approval of funds in anticipation of needed to support a youth member to the national conference, approximately \$1,000 per year. Gary Cayo amended requested to stated monies only needed if local youth selected. Motion to accept made by M. Servatka, seconded by E. Johnson; motion approved.
