## **The Officer Scott Patrick Memorial Police Explorer Scholarship**

On July 30<sup>th</sup>, 2014, Mendota Heights Police Officer Scott Patrick was killed in the line of duty on a traffic stop in the City of West St. Paul, Minnesota. Officer Patrick was shot and killed by a man with active warrants for his arrest, was a known drug dealer and a convicted felon. Officer Patrick left behind his wife, two daughters, his extended family, and his friends/colleagues in law enforcement. His death also tragically scarred the community in which Scott was born, worked, and raised his family. Scott was raised in St. Paul Minnesota, where he attended Humboldt Senior High School and was a member of the St. Paul Police Department Explorer Post. He went on to obtain his degree in Law Enforcement from Alexandria Community College.

Scott was a dedicated father, brother and husband and a fixture in his community. He died serving a community he dearly loved. He was a man of integrity, character, intelligence and passion. He always knew the right thing to say at the right time and he definitely knew how to make people laugh. Scott knew from a young age that he wanted to become a police officer and serve his community and he worked diligently to achieve that goal. Scott's life ended far too soon and he gave the ultimate sacrifice. In honor of his service and sacrifice, this memorial scholarship was created by his family and the members of the Mendota Heights Police Officer Benevolent Association (MHPOBA).

### **The AWARD**

An award of \$1,000 will be awarded to a high school senior/or enrolled college student at the Minnesota Law Enforcement Explorer Conference in April 2017.

### **Who is ELIGIBLE?**

Any MN Law Enforcement Explorer who is currently in 12<sup>th</sup> grade (or above) and is in current good standing with their post, and has post-high school plans (or is attending college) to pursue a career in law enforcement. The applicants will be evaluated on their academic record, leadership ability, extracurricular activities and personal essay.

### **Application Process**

- Complete the application, which must be signed by applicant and Explorer Advisor.
- Be a current registered Explorer of a MN Law Enforcement Explorer Post.
- Complete the required essay
- Submit a transcript of his/her high school record (or current college transcript).
